In pursuance of the powers conferred under Section 18 of the Right of Children to Free and Compulsory Education Act, 2009 and Rule (5) (1) of the Right of Children to Free and Compulsory Education Rules, 2012 and under the Mumbai Primary Education Rules, 1949, permission is hereby granted to start a new unaided private primary school from June 2025 on the basis of the online application received from your school board and the enclosures attached with the application, subject to the following conditions.

The medium of instruction in your school will be English and from June 2025, you will be able to run only one class each from Standard 6 to 8.

#### Conditions:-

- The school board will be responsible for fulfilling and maintaining the conditions of the school's accreditation.
- 2. The school board will be responsible for following and implementing all the provisions of the Right of Children to Free and Compulsory Education Act-2009 and the Right of Children to Free and Compulsory Education Rules-2012 and the Gujarat Primary Education Act-1947 and the Mumbai Primary Education Rules 1949.
- 3. In addition to the Act and the rules framed thereunder, the school board shall be responsible for complying with the rules, bye-laws, resolutions, circulars, instructions, etc. promulgated by the State Government from time to time.
- 4. The school should admit children from weaker sections and disadvantaged groups in the nearby area in standard-1 including pre-primary classes as per 25% of the strength of that standard and should provide free and compulsory elementary education till its completion. For its implementation, the concerned office should be contacted.

- 35. Violation of any one or more of the above conditions along with the school's accreditation will result in action up to and including cancellation of the school's accreditation. The school board should take special note of this.




